

## **Information**

We hereby describe the procedures of the users' personal data management finalized to allow the on-line registration and/or the enrolment to the conference and/or institutional events organized and managed by the Triumph Group International S.p.A..

The information is given according to the section 13 of the legislative Decree n. 196/2003 – Personal Data Protection Code. The Holder of the data treated and utilized to submit the on-line registration is the Triumph Group International S.p.A., based in Via Lucilio n. 60 – Rome (Italy), 00136.

The treatments related to the web services of this site take place in the office of the Triumph Group International S.p.A. and are handled by the personnel of the company in charge of the treatment, as well as by eventual responsible of occasional maintenance operations. Rights of the persons concerned the subjects whose personal data refer to, have the right in any moment to get the confirmation of the existence of the data and to get acquainted with their content and source, verify the rightness or ask integrations or update, or amendments (section 7 of the legislative decree n. 196/2003). The same Decree section states the right to ask for the cancellation, transformation to anonymity or blocking of the data only if they are treated in breach of the law, as well opposing in any case, for legitimate reasons, to their treatment. The requests have to be addressed to the Triumph Group International S.p.A., at the main office, in quality of Holder of the treatment. Kind of treated data When a user submits the on-line registration, we ask to insert some personal data (in particular personal information and contact information, photos) as well the personal data of the accompanying person if there is one.

The personal data given by the users that submit the on-line registration, are used by the Triumph Group International S.p.A. for the sole scope to supply the required service. The data are not given or communicated to third parties, except when imposed by the law or when it is necessary to comply with the requests. The user is free to give the personal data requested in the forms, but in some cases the lack of some data (personal, e-mail, telephone) can cause the impossibility to get the service. We hereby communicate that the credit card number or other payment methods information can be requested.

Such data, required when it is intended to book a hotel, could be communicated to third parties (i.e. Hotels) for the aims strictly connected to the fulfilment of the contract (security of the reservation). In order to perform the contractual activity, it could be appropriate and/or necessary for the user that registers on-line to indicate also sensitive data (i.e. particular food exigencies, eventual physical handicaps). In these hypotheses, the law requires the written consent of the person concerned that, at this scope, has to download the provided form and send it signed via fax (or e-mail a scanned version).

If the user does not give the written consent to the treatment of the above mentioned data, the Triumph Group International S.p.A. cannot guarantee the quality of the service offered to the user. The personal data given by the user for further aims (such as subsequent congress information, commercial promotions, market research) will be used exclusively for the above mentioned further aims and can be communicated to third parties only if necessary (i.e. promotions mailing).

The Triumph Group International S.p.A. elaborates the personal data only for the aims described in the privacy policy and/or in the additional information about the privacy or specific services. Besides the above mentioned, such aims include:

- Commercial promotions of the Triumph Group and events; Examination, research and analysis activities aimed to manage, protect and improve our services;
- Treatment Modalities and Information Protection Personal data are treated with automated instruments for the time strictly necessary to attain the aims for which they have been gathered. Specific security measures are applied to prevent data loss, illicit or non-correct uses and unauthorized accesses. The treated personal data will be constantly updated and complete, and, for this scope, we invite the users to send notifications to do updates and corrections if necessary. The access to the personal data is limited to the employees and external collaborators of the Triumph Group International S.p.A. who need such information to carry-out the own activity, as well to manage, develop and improve our services.
